Specification – Oasis one-piece FRP gelcoat shower compartment SHFW-WX-3837, having a 36 x 36-inches clear interior dimension and ½-inch high maximum finished threshold with floor attachment flange on lower threshold, and expanded shower entry wall reveal to minimize transfer space from wheelchair-to-shower seat. An ActivLife factory-applied reinforcement only package, in compliance with HUD-FHA Fair Housing Act Design Manual, shall include back wall reinforcement for horizontal bar application, reinforcement for vertical & horizontal bar application on both side walls, and seat reinforcement on both side walls.

Standards Certification:

The shower compartment listed is manufactured in compliance with ANSI Z124 Standards, and certified through an ongoing, independent quality assurance and testing program.

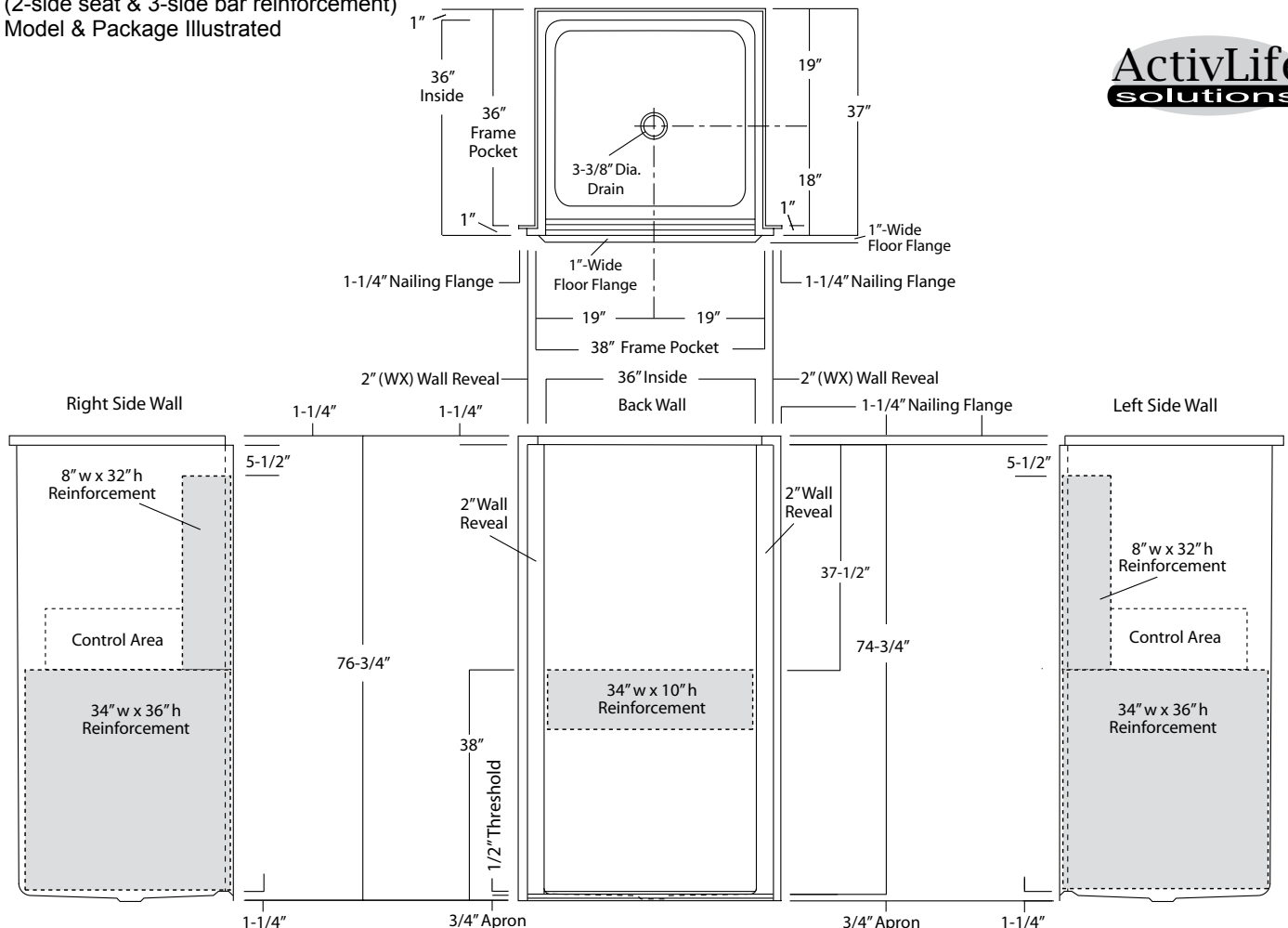
